NOTICE OF SEARCH AND CALL FOR APPLICATIONS

The Bukidnon State University Board of Regents formally and publicly announces that the Search for the Private Sector Representative in the Governing Board is still open.

The Following are the required minimum qualifications and documentary requirements:

A. Applicants must possess the following minimum qualifications:

1. Must be a resident (domicile) of Bukidnon Province at least 6 months prior to the submission of application;
2. Must be 31 years or older;
3. Must not in any way connected with the University in any manner, for two years prior to the application;
4. Must be from an industry, business or profession related to the University legal mandates;
5. Must have knowledge and expertise and depth and breadth of experience to the deliberations and work of the Governing Board;
6. Must be able to participate in all meetings and undertakings of the Governing Board and its committees whenever and wherever agreed upon;
7. Must be able to effectively link the University and its programs to the people of the communities;
8. Must not any way be presently employed or appointed to any position with any government (local, national, and in government owned and controlled corporation) agency or entity, in any manner, be it fulltime or part time, at the time of his or her nomination for the Private Sector Representative position;
9. If the PSR applicant previously worked in any capacity with a government entity or was a consultant in any government undertaking of whatever nature, the proportion of the time the applicant served in government shall not exceed one half of the entire time the applicant served in the private sector; and
10. Must have an extensive record of employment, business, expertise and connection with the private sector.

4. One-page personal vision and mission statement for the university including core values that the applicant is advocating.
